<p><b>I. After acceptance</b></p> <p>During the production phase the following issues have to be clarified.</p> <p><b>I-1. Requirements for Electronically Produced Illustrations</b></p> <p>After acceptance of the manuscript, the publisher may require figure files prepared according to the specifications defined at <a href="http://www.springer.com/journal/12194">www.springer.com/journal/12194</a>.</p> <p><b>I-2. Open Choice</b></p> <p>In addition to the normal publication process (whereby an article is submitted to the journal and access to that article is granted to customers who have purchased a subscription), Springer now provides an alternative publishing option at a cost to the author: Springer Open Choice. A Springer Open Choice article receives all the benefits of a regular subscription-based article, but in addition is made available publicly through Springer's online platform SpringerLink.</p> <p>The basic fee for Springer Open Choice is USD 3,000 / EUR 2,200; excl. VAT. Invoicing will be done according to the location of the paying party (designated in the "Bill to" section of the Order Form). Customers providing payment from North and South America will be charged in US dollars, and customers providing payment from Europe, Africa, and Asia will be charged in Euros. Copyright</b></p> <p>All authors must sign a Copyright Transfer Statement before an article can be published. Offprints/Reprints</b></p> <p>Upon publication the corresponding authors will receive either an electronic offprint (PDF-format) or 30 printed offprints of their article free of charge. Additional offprints can be ordered by the corresponding author.</p> <p><b>I-5. Color Print</b></p> <p>The online and print publication of color illustrations is free of charge.</p> <p><b>I-6. Online First</b></p> <p>The article will be published online after receipt of the corrected proofs. This is the official first publication citable with the DOI. After release of the printed version, the paper can be cited by issue and page numbers.</p>	<p><b>I. After Acceptance</b></p> <p>Upon acceptance of your article you will receive a link to the special Author Query Application at Springer's web page where you can sign the Copyright Transfer Statement online and indicate whether you wish to order OpenChoice and offprints. Once the Author Query Application has been completed, your article will be processed and you will receive the proofs.</p> <p><b>I-1. Copyright</b></p> <p>All authors must sign a Copyright Transfer Statement before an article can be published. This transfer agreement enables JSRT and JSMP to protect the copyrighted material for the authors, but does not relinquish the authors' proprietary rights.</p> <p><b>I-2.
